6. Hence, I award a compensation of Rs. 2,000/- (Two Thousand Only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of Jasbir Singh from the account of Public Authority and not from the individual's account.

7. Respondent PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.
