The representative of the respondents is present along with the original record concerning Point No. 3 i.e. copies of NOCs attached along with the sale deed from 1.1.2020 to 21.3.2020 as per the last orders of the Commission. Regard Point No. 1 of the RTI application the representative of the respondents states that the information has already supplied to the appellant and the same can also be seen at the website of GLADA i.e. www.glada.gov.in.

4. After inspection of the concerned record, the Commission observes that no NOC has been attached along with the sale deed from 1.1.2020 to 21.3.2020 as has been sought by the appellant. Also the respondent-Public Information Officer has filed the specific reply which is reproduced below:-

With regard to the remaining points of the RTI application, the same has already been replied by the respondent-Public Information Officer vide letter No. 274 dated 24.11.2020. The appellant is not present today but has made the submissions through email that he has not received any information so far.

4. The appellant has sought the four point information from the respondent-Public Information Officer the information pertaining to Point No. 1 is available on the website so the submissions made by the respondents are accepted. Regarding Point No 2, 3 and 4 of the RTI application, the respondents have already supplied the information vide letter No. 274 dated 24.11.2020 and the Commission accepted the response given by the respondents. A copy of the reply sent by the respondent-Public Information Officer vide No. 274 dated 24.11.2020 is **sent** with this order.
