In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.5000/- (Rupees Five Thousand Only)** is awarded to the Appellant as compensation. I order accordingly.
6. This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission.
