2. The appellant is present today. He states that the information supplied is incomplete and the same is unattested. He further states that the BDPO Fazilka has not made payment of the compensation amount of Rs.4000/- till date.
3. Shri Parvesh Singh, BDPO-cum-PIO, Fazilka, is absent today without any intimation to the Commission. On the previous date of hearing he was directed to pay the compensation of Rs.4000/- to the appellant through cheque / demand draft from the Funds / Account of the Public Authority and submit a copy of the same to Commission as a token of having made the payment to the appellant but it has been noted that he has not bothered to do so till date. He is once again directed to make the payment of compensation of Rs.4000/- to the appellant within 10 days through cheque / demand draft from the Funds / Account of the Public Authority and submit a copy of the same to Commission as a token of having made the payment to the appellant.
4. The Commission takes a serious view of this lapse on the part of respondents for taking orders of the Commission in a casual manner and thus, denying the appellant his legitimate right to get the sought for information. Therefore, viewing the delaying attitude of the respondent-PIO, a Show Cause Notice under Section 20(1) of the RTI Act 2005, is issued to Shri Parvesh Singh, BDPO-cum-PIO, Fazilka, to explain the reasons through a duly attested affidavit as to why a penalty at the rate of Rs.250/- per day subject to maximum of Rs.25000/- be not imposed upon him for the delay in the supply of information. He is also afforded an opportunity of personal hearing on the next date of hearing before taking any action.
