**ORDER:**

The appellant through RTI application dated 22.04.2019 has sought information regarding security of the Purab Premium Apartments sector 88 Mohali – contact for security, persons employed, amount incurred and other information concerning the office of GMADA Mohali. If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such persons of the show cause and direct them to appear before the Commission along with the written replies.

The PIO is again directed to provide the information within 15 days.
