**ORDER:**

The appellant through an RTI application dated 03.09.2020 has sought information regarding a file relating to a letter dated 27.08.2019 of the Department of administrative reforms, alongwith complete noting and other information as enumerated in the RTI application, from the office of SDM Balachaur. The appellant was not provided with the information after which the appellant filed the first appeal before the First Appellate Authority on 05.10.2020 which took no decision of the appeal.

The case has already been heard by Ms.Preeti Chawla, State Information Commissioner on 02.06.2021, 28.07.2021 & 24.08.2021. On the date of the last hearing on 24.08.2021, the respondent was absent and due to non-supply of complete information, the PIO was issued a **show-cause notice** under section 20 of the RTI Act and directed to file a reply on an affidavit.

The case has come up for hearing today before this Bench through video conferencing at DAC Nawanshahar. The appellant is absent and vide letter received in the Commission on 07.01.2022 has informed that the PIO has not supplied the information.

The Commission has received a letter from the PIO on 03.01.2022 which has been taken on record.

I have gone through the reply of the PIO and find that the reply is vague and the respondent has not applied his mind while attending to the RTI application. The PIO is directed to reconcile the RTI application and provide information to the appellant as per the RTI application. The PIO is also directed to file a reply to the show-cause notice.

The case is adjourned. To come up for further hearing on **11.05.2022 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Ludhiana. The PIO to appear through VC at DAC- SBS Nagar, Nawanshahar.

**ORDER:**

The appellant through an RTI application dated 24.04.2021 has sought information on 05 points cardholders' details relating to depot holder Smt.Surinder Kaur ward No.59, Kila Mohalla, Daresi Road, Ludhiana – detail of the wheat supplied to each member of the family – wheat supplied in the full year to a cardholder – detail of wheat allotted to a depot holder and other information as enumerated in the RTI application from the office of District Controller, Food Supply Department, Ludhiana. The appellant was not provided with the information after which the appellant filed the first appeal before the First Appellate Authority on 08.06.2021 which took no decision of the appeal.

The case has come up for hearing **today** before Bench through video conferencing at Ludhiana. The appellant claims that the PIO has not supplied the information.

The respondent is absent nor is represented. There has been an enormous delay of more than nine months in providing the information. The Commission has taken a serious view of this and hereby directs the PIO to **show cause why penalty be not imposed on him under section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time as well as for misleading the court. He/she should file an affidavit in this regard.** If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such person(s) of the show cause and direct them to appear before the Commission along with the written replies.

The PIO is again directed to provide information to the appellant within 15 days of the receipt of the order and send a compliance report to the Commission.

The case is adjourned. To come up for further hearing on **30.05.2022 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Ludhiana.

The appellant is given one more opportunity to appear before the Commission on the next date of hearing to reconcile the information.
