Accordingly, the PIO is given another opportunity to comply with the directions of the Bench in its entirety before the next hearing.

The Bench observes that the respondent must provide these details on priority.

6. In view of the above, the PIO is directed to supply information to the appellant on Point No.9 within next seven days. The representative of PIO assures to do the needful.
