As per the reply submitted the SPIO it is clear that the SPIO is not personally liable for the delay in providing the information to the appellant, so the show cause notice issued to him is hereby dropped and filed.

As the SPIO has provided the sought for information to the appellant, so the present appeal case is **disposed of and closed.**
