2. Sh Jasbir Singh is appearing on behalf of the Appellant without authority letter.


3. The Respondent states that he has got the complete information today. Copy of the same is handed over to the representative for the Appellant.

2. The information sought by the Complainant from O/o Assistant Registrar, Cooperative Societies, is similar in all the above-mentioned cases so all the cases are clubbed.


