Appeal Case No. 763 of 2019

Present : Sh. Ramandeep Singh Ahluwalia, the appellant in person.
Sh. Charanjit Singh, Executive Officer-cum-PIO, in person.

ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.
The RTI request is dated 05.10.2018. First appeal is dated 27.11.2018. Second appeal has been received in the Commission on 20.02.2019.

On the last date of hearing, held on 31.03.2021, Sh. Charanjit Singh, Executive Officer-cum-PIO, stated that available information was supplied to the appellant and part information is not found traceable in the office-record and FIR was lodged vide letter no. 2415 dated 25.03.2021 to the office of Sr. Supdt. of Police, Khanna. The appellant stated that incomplete information was given to him. An opportunity was given to the appellant to visit the office of the respondent PIO on 01.04.2021 at 03:00 P. M. to collect the remaining information. The respondent PIO concerned was directed to supply the remaining information at point no. 02 and 03 of the RTI request, to the appellant during his visit to office on 01.04.2021 at 03:00 P. M. and take acknowledgement of having received the requisite information. If any information, to any query/queries raised by the appellant through RTI request, is not available or not maintained in the official record, he/she (respondent-PIO concerned) was directed to send/file a reply, in writing, to the particular query/queries, to the appellant with a copy to the Commission. An opportunity was also given to the appellant to confirm whether he has received the information after inspection.

The appellant, Sh. Ramandeep Singh Ahluwalia, who appeared in person in today's hearing, states that remaining information at point no. 02 and 03 of the RTI request has not been received till date.

Sh. Charanjit Singh, Executive Officer-cum-PIO, who appeared in person in today's hearing, states that available information has already been supplied to the appellant vide letter no.216 dated 06.10.2020 and a reply dated 26.06.2021 has also been given to him, intimating that the part information at point no. 02 and 03 of the RTI request regarding circular and notification relates with office of Director, Local Government, Punjab and can be collected from that office. He also intimates the Commission that a reply, in an affidavit, has also been sent to the Commission vide letter dated 26.06.2021, which has been received in the Commission through an e-mail. It is taken on record.

Since available information as per official record stands supplied and no cause of action is left in the instant appeal case, hence, the case is announced as disposed of and closed with the directions to the respondent PIO to send the original affidavit to the appellant positively.

Present : None on behalf of the appellant.
Sh. Madanjit Singh, Assistant Town Planner, Zone – D, for the respondent.

ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 09.09.2019. First appeal is dated 14.10.2019. Second appeal has been received in the Commission on 20.12.2019.

On the last date of hearing, held on 31.03.2021, Sh. Madanjit Singh, Assistant Town Planner, Zone – D and Sh. Harjit Singh, Draftsman, Zone-D, stated that the available information was supplied to the appellant vide letter no. 361 dated 29.12.2020 and the appellant had not pointed out any deficiency till date as directed vide orders dated 04.01.2021. The appellant orally intimated that part information, regarding building names, had not been supplied to him by the respondent PIO till date. On this, representatives of the respondent states the above-said part information is not available in the official record and relates with office of G. L. A. D. A., Ludhiana. Last opportunity was given to the respondent-PIO concerned to send a point wise reply to the remaining information regarding buildings mentioning particular query/queries raised by the appellant through his RTI request to the appellant to the appellant with a copy to the Commission.

Sh. Madanjit Singh, Assistant Town Planner, Zone – D, who appeared on behalf of the respondent PIO in today's hearing, states that the requisite information of nineteen buildings has been supplied to the appellant vide letter no. 100 dated 18.06.2021 as per official record through Speed-post. He also intimates the Commission that a reply has also been sent to the Commission vide letter no. 6826 dated 04.12.2020, which has been received in the Commission vide Diary No. 13707 dated 23.06.2021. It, alongwith a copy of postal-receipt, is taken on record.

The appellant, Sh. Gagandeep Singh Threekey is absent from today's hearing without any intimation to the Commission. He has neither pointed out any deficiency in the information supplied to him, to the respondent-PIO, nor approached the Commission with any contrary claim in that regard.
