#### ORDER:

The respondent present pleaded that the appellant was asked to vide letter dated 26.11.2020 to deposit requisite fee of rs.162/- for getting the information which the appellant did not deposit and filed an appeal before the First Appellate Authority on 25.11.2020. The appellant vide his letter dated 30.12.2020 again represented that since he was not asked to deposit the fee within the time period of 15 days as prescribed under the RTI Act., the information be provided free of cost.
