Smt. Rajinderjit Kaur, BDPO, Chohla Sahib, Distt. Tarn Taran is present.

**O R D E R**

Shri Gurinder Singh, complainant/applicant filed RTI application dated 23.01.2019 and sought some information from the office of the SPIO.

**Today the case is heard through CISCO Webex Meetings Software.**

Shri Gurinder Singh, complainant/applicant is absent today, whereas Smt. Rajinderjit Kaur, BDPO, Chohla Sahib has appeared in today's hearing.

I have gone through the previous Orders passed by the Commission in the present complaint case. The information sought by the complainant/applicant has already been provided to him by the SPIO.

A penalty of Rs.25,000/- was imposed upon Ms. Prabhjot Kaur, SPIO-cum-Panchayat Secretary, Gram Panchayat Dehra Sahib, Block Chohla Sahib, now transferred to Block Naushehra Pannua, Distt. Tarn Taran and a penalty of Rs.25,000/- was imposed upon Mr. Sarabjit Singh, SPIO-cum-Panchayat Secretary, Gram Panchayat, Jhander Mahapurkhan, Block Chohla Sahib and a penalty of Rs.25,000/- was imposed upon Mr. Jagdish Singh, SPIO-cum-Panchayat Secretary, Gram Panchayat, Karmuwala, Block Chohla Sahib vide Order dated 16.01.2020 and the BDPO, Chohla Sahib and the BDPO, Naushehra Pannua were directed to deduct the amount of penalty from the salaries of the concerned SPIOs-cum-Panchayat Secretaries and deposit in the Govt. Treasury.

The Commission has received an e-mail sent by the BDPO, Chohla Sahib, which is a copy of letter no.84 dated 13.07.2020 along with copy of E-challan receipt no. 129820 dated 30.06.2020, receipt no. 129890 dated 30.06.2020 and receipt no.152708 dated 09.07.2020.

I have gone through the said letter and it is submitted by the BDPO, Chohla Sahib that the penalty of Rs.25,000/- has been deducted from the salary of Ms. Prabhjot Kaur,

SPIO-cum-Panchayat Secretary, Gram Panchayat Dehra Sahib, Block Chohla Sahib, now transferred to Block Naushehra Pannua, Distt. Tarn Taran and the penalty of Rs.25,000/- has been deducted from the salary of Mr. Sarabjit Singh, SPIO-cum-Panchayat Secretary, Gram Panchayat, Jhander Mahapurkhan, Block Chohla Sahib and the penalty of Rs.25,000/- has been deducted from the salary of Mr. Jagdish Singh, SPIO-cum-Panchayat Secretary, Gram Panchayat, Karmuwal, Block Chohla Sahib and deposited in the Govt. Treasury.

As the sought for information has been provided to the complainant/applicant and the amount of penalty of Rs.25,000/- each have also been deducted from the salaries of concerned SPIOs-cum-Panchayat Secretaries and deposited in the Govt. Treasury, so the present complaint case is **disposed of and closed**.

As per the Order dated 16.01.2020, the disciplinary action was recommended against Ms. Prabhjot Kaur, Mr. Sarabjit Singh and Mr. Jagdish Singh, SPIOs-cum-Panchayat Secretaries under service rules applicable to them and a copy of Order was sent to the Director, Rural Development and Panchayats, Punjab for taking disciplinary action against the above said Panchayat Secretaries.

But no compliance regarding the disciplinary action has been received in the office of the Commission. So, again a copy of Order be sent to the Director, Rural Development and Panchayats, Punjab for taking disciplinary action against the above mentioned SPIOs-cum-Panchayat Secretaries.
