**ORDER**

1. The RTI application is dated 14.11.2018 vide which the complainant has sought information as enumerated in his RTI application and complaint was filed in the Commission on 20.02.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 28.07.2020 in the Commission.
3. Respondent, ASI Ramesh Kumar states that requisite information relates with 29 Police stations (Thana) and each and every Police station have many chowki(s) under jurisdiction. He added that every police station have different PIOs. He further states that reply vide letter no. 4251 dated 19.11.2018 has already been sent to the complainant in this regard that stating that he can collect the requisite information from the concerned police stations after filing RTI application.
4. Complainant, Sh. Parminder Singh attended the hearing through CISCO WEBEX but, he didn't respond to the Commission after many calls to him during the hearing.
5. After hearing the respondent and examining the case file, it is observed that requisite information is too voluminous as it relates with 29 police stations. The representative of the respondent states that those 29 police stations are the custodian of the record and list of 29 police stations was supplied to the complainant with the reply (letter no. 4251 dated 19.11.2018).

I am of the considered view that information to be collected, collated, tabulated and rearranged is not within the purview of the RTI Act in accordance with the decision given by the State Information Commission, Punjab in **CC No. 2177 of 2010 (DOD 2.8.2010).**

Commission is of the view that the Public Information Officer o/o SSP, Ludhiana should not have transferred the RTI applications under Section 6(3) to more than one public authority considering the provisions of the RTI Act, 2005 and the instructions issued by the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training vide O.M. No. 10/2/2008-IR dated 12.6.2008 in this regard. In accordance with these directions, the complainant is advised to make the application afresh to the remaining 29 public authorities in case he wants to seek the information.

6. In wake of above, no further cause of action is required in this case. Therefore, the instant complaint case is **disposed of & closed**.
