ORDER:

The appellant through RTI application dated 02.01.2020 has sought information regarding the copy of the information sent to PMO Office New Delhi with reference to complaint PMOPG/E/2019/0384193 – day to day action taken on the said complaint – status of the complaint and other information as enumerated in the RTI application from the office of Principal Secretary Govt of Punjab, Chandigarh which transferred the same to Principal Secretary, Local Govt. Pb Chandigarh on 05.02.2020. The appellant was not provided with the information after which the appellant filed the first appeal before the First Appellate Authority on 14.09.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Mohali. The respondent present pleaded that the appellant had filed different RTI applications with different departments/organizations for seeking exactly the same information regarding tenders floated by MC Patiala for Dog Sterilization. As per the respondent, all the complaints were marked to the Principal Secretary, Local Bodies who further marked it to the Chief Vigilance Officer, Local bodies. As per the respondent, on completion of the enquiry, the case for further action against the guilty officers/officials has been referred to the Govt vide letter dated 15.06.2021.

The respondent further informed that the appellant has already inspected the complete record file on 16.03.2021 and given in writing that he is satisfied with the information and his all appeal cases filed up to 16.03.2021 be closed. The respondent has also submitted his reply along with the acknowledgement/statement of the appellant to the Commission which has been taken on the file.

Since the information has been provided and the appellant has put in a request to the Local Bodies Department to close all appeal cases filed up to 16.03.2021, no further course of action is required. The case is **disposed of and closed**.
