A Show Cause Notice was issued to the SPIO, O/o District Food Supply Controller, Ferozepur vide Order dated 05.03.2021 passed by the Hon'ble Chief Information Commissioner, Ld. Shri Suresh Arora and the SPIO was directed to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay/denial of the information to the RTI application.

The Commission has received an e-mail sent by the SPIO, which is a copy of duly attested affidavit dated 04.05.2021 as reply to the Show Cause Notice along with a copy of letter noi.845 dated 05.05.2019 and copy of letter no.1406 dated 03.05.2021.

I have gone through the reply to the Show Cause Notice and it is submitted by the SPIO that the RTI application dated 11.02.2019 filed by the appellant was not received in the office of the SPIO directly rather it has been received from the office of the Director, Food and Supply, Punjab, Chandigarh vide letter no.1106 dated 09.04.2019. He further stated that the information was related with the distribution of ration at village Megha Rai HIthar, so the RTI application of the appellant was transferred to the concerned Inspector vide leter dated 08.05.2019. It is further submitted by the SPIO that as per the report by the concerned Inspector, the appellant himself is the depot holder of village Megha Rai Hithar, therefore the
