The RTI route is not the correct route to obtain such information. However, as a special one time waiver Naib Tehsildar is being directed to provide the same, free of cost. On the directions of the Bench the Naib Tehsildar hands over a copy of the documents to the representative of the appellant in front of the Bench itself, with which he is satisfied and gives his consent to close the case.

The same had already been conveyed to the Appellant vide letter 30.12.2020 but still the fees had not been deposited by the Appellant till date. He further states that this information can also be taken from Suvidha Kender (online) by paying the concerned fees to them.

4. As per the Government Rules and Regulations, the land and revenue record can only be obtained from the Suvidha Kender or physically from the office of Naib Tehsildar / Patwaris on payment of prescribed fees. The RTI route is not the correct route to obtain such information. However, as a special one time waiver Naib Tehsildar is being directed to provide the same, free of cost. On the directions of the Bench, Naib Tehsildar hands over a copy of the documents to the representative of the appellant in front of the Bench itself, with which he is satisfied and gives his consent to close the case.

5. No further action is required. This case is **disposed off and closed.** Copies of the order be sent to the concerned parties.
