I am of the view that due to evasive attitude and irresponsible behavior of the respondent PIO concerned, the appellant has suffered many detriments for not getting the requisite information and/or not getting it in time, therefore, I am of the view that an interim compensation be awarded to the appellant, **Sh. Kuldip Kumar Kaura**.
7. Hence, I award an interim compensation of Rs. 1000/- (One thousand only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of **Kuldip Kumar Kaura** from the account of Public Authority and not from the individual's account. The respondent must send a copy of above said cheque or DD, to the Commission. Respondent PIO is also given one more opportunity along with directions to retrieve the requisite information from the concerned department and provide certified copy of it to the appellant by the next date of hearing.
8. Deputy Director, Sh. Subhash Mahajan, O/o DPI (SE), Punjab, Mohali is directed to appear in person to clear the facts of this case on next date of hearing. He is also directed to provide requisite information and/or written reply satisfying the RTI application, failing to which action under section 20 (1) of RTI act would be initiated against him if found delinquent.
