ORDER:

1. This order may be read with reference to the order dated 19.08.2020 passed by this Bench on the previous date of hearing.
2. The case was scheduled to be heard today through Cisco Webex. However, Shri Ramandeep Singh Ahluwalia, appellant attends the hearing in person before the Bench at Chandigarh. He states that as directed on the previous hearing, he visited the office of PIO on 27.08.2020. After inspection, he identified the documents and requested the PIO to supply the same which were received by him later on by registered post vide letter dated 31.08.2020. The appellant points out that the documents supplied are uncertified.
3. Shri Gurinder Singh, Superintendent O/o Municipal Council, Khanna comes present in person before the Bench at Chandigarh. He states that he has brought along the affidavit to the effect that information as identified by the appellant has been supplied by registered post. On the asking of the Bench, he hands over the original affidavit to the appellant during the hearing and submits photocopy of the same to the Bench.
4. The appellant requests the Bench to direct the representative of PIO to provide the information duly certified by the PIO as the information earlier supplied to him is uncertified. On the asking of the Bench, Shri Gurinder Singh, the representative of the PIO assures to provide the appellant certified copies of the documents when the appellant visits their office on 12.10.2020. Appellant agrees to the same.

ORDER:

1. This order may be read with reference to the order dated 19.08.2020 passed by this Bench on the previous date of hearing.
2. The case was scheduled to be heard today through Cisco Webex. However, Shri Ramandeep Singh Ahluwalia, appellant attends the hearing in person before the Bench at Chandigarh. He states that as directed on the previous hearing, he visited the office of PIO on 27.08.2020, but no record was produced to him for inspection and is being harassed.
3. Shri Gurinder Singh, Superintendent O/o Municipal Council, Khanna comes present in person before the Bench at Chandigarh. He states that he has brought along the affidavit stating therein the position with regard to RTI application, to the effect that no log book for the vehicle was started and the due payments were made in pursuance of the resolution and its approval from the Government, as also from the competent authority. It has been further stated in the affidavit that the resolution was placed for purchase of new vehicles as the vehicles of Municipal Council, Khanna were very old and not in working condition and that there is no record available with the Municipal Council, Khanna regarding meeting of Condemnation Committee. On the asking of the Bench, the representative of the PIO hands over original affidavit to the appellant during the hearing and submits photocopy of the same to the Bench for record.
