Order

This order may be read with reference to the previous order dated 28.8.2020 vide which the case was adjourned to 9.10.2020 but further adjourned to 28.10.2020 due to administrative reasons.

2. The appellant has sought the following information of Geeta Rani w/o Shri Sangit Manjhatra working in Seva Kender, Ludhiana for the period of year 2009 which is reproduced as follows:

3. ਗੀਤਾ ਰਾਨੀ ਦੀ ਤਨਖਾਹ ਵਿੱਚੋਂ ਮਹੀਨਾ ਕਿਤਨੀ ਕਟੌਤੀ ਕੀਤੀ ਜਾਂਦੀ ਹੈ। ਜਿਵੇਂ ਪੀ.ਐਫ. ਅਤੇ ਹੋਰ ਕਟੌਤੀਆਂ ਦੀਆਂ ਨਕਲਾਂ /ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।
4. ਗੀਤਾ ਰਾਨੀ ਦੀ ਜੁਆਇਨਿੰਗ ਮਿਤੀ ਅਤੇ ਫੂਲ ਐਂਡਰੈਸ ਸੇਵਾ ਕੇਂਦਰ ਦਾ ਦੱਸਿਆ ਜਾਵੇ।

3. Today, the office contacted the appellant who informed that he is busy but will attend the hearings through video conference in case he is absent he will be available at the Cisco Webex/phone. But during the hearing the appellant remained absent at the video conference and the office tried to contact him on phone twice during the hearing but the appellant neither picked up the call nor replied. As far as his written submissions are concerned the same has been received in the Commission through email dated 1.9.2020, which are taken on record.

4. The representative of the respondent has reiterated the same statement as in hearing dated 11.6.2020 and 28.8.2020, that the information relates to the 3rd party and cannot be supplied as per the provisions of the RTI Act, 2005. He further states that the appellant has sought the same information in the appeal case no. 540 of 2020 in respect to Smt. Geeta Rani who is daughter in law of the appellant and has a marital discord and does not give her consent to share the information with the appellant. The representative of the respondents reiterates that this case was heard by Hon'ble Lt. Gen. Ajai Kumar Sharma (Retd.) State Information Commissioner and the information was denied under section 8(1)(j) of RTI Act 2005 and the case was disposed of on 4.3.2020.

6. Accordingly, the bench called for the concerned file and after going through the RTI application of both the files, it has transpired that the appellant has sought the same information in both the case.

7. According to the above, it has transpired that the case of the appellant, in which the similar information has been sought and the Commission has disposed of the same. It is also a fact on record that the appellant is having the family dispute with Ms Geeta Rani. It is also a fact on record that the appellant has not made any submissions in getting the 3<sup>rd</sup> party information/larger public interest in seeking the information. Furthermore, the appellant has been uncooperative.

9. After going through the case, conduct of the appellant in not attending the hearing, non submissions of larger public interest involved in seeking the 3<sup>rd</sup> party information, the case regarding the same information sought by the appellant i.e. Appeal Case No. 540 of 2020, which had already disposed of by the Commission and the sought information relates to the family dispute, it is observed that the appellant failed to establish the larger public interest as well as due to absence of the appellant during the hearing although the facility of video conference/cisco webex/phone was extended to him, an ex-parte decision is taken. So no further action is required in this case. Therefore, the case is disposed of and closed.

### **ORDER**
