For the respondent: Sh. Aashish Tonk (SDE).

ORDER

1. This order may be read with reference to the previous order dated 12.11.2018.
2. Respondent, Sh. Aashish Tonk states that requisite information has already been supplied to the appellant.
3. On this, appellant, Sh. Jaswinder Singh states that information only relates with point no. 1 has been received from the respondent and rest of the information is still pending from the respondent PIO.
4. After hearing both the parties and examining the case file, it is found that on the first hearing held on 08.11.2017, respondent Sh. Vikas Sharma (Superintendent) was appeared late after the hearing was over. He stated that applicant was intimated through a letter dated 05.04.2017 to inspect the official record as per his RTI application. He further mentioned that requisite information has already been sent to the applicant through registered post dated 06.11.2017 and matter was adjourned for further hearing on 11.12.2017.
5. On previous hearings:
 - On hearing held on **11.12.2017**, it was observed that Sh. Vikas Sharma does not aware about the facts of this case. Respondent PIO, Sh. S. K. Sharma was directed to appear in person along with requisite information as per RTI application on the next date of hearing and matter was adjourned for further hearing on 16.01.2018. A copy of order was sent to him through registered post by name.

- On hearing held on **16.01.2018**, respondent PIO, Sh. Tejaswi Swaroop Singh handed the requisite information to the appellant during the hearing. Applicant, Sh. Jaswinder Singh requested the Commission for an adjournment to go through the information received. After hearing both the parties and going through the documents placed on records, the appellant was advised to go through the information received during the hearing as said above and point out deficiency if any to the respondent PIO in written and also a copy of it to the Commission by the next date of hearing failing to which the case would be considered as for non-pursuance by the appellant and matter was adjourned for further hearing on 16.02.2018. Hearing which was earlier fixed for 16.02.2018 was postponed and matter was adjourned for further hearing on 19.03.2018.
- On hearing held on **19.03.2018**, Applicant, Sh. Jaswinder Singh stated that he has intimated regarding the deficiencies in the supplied information to the respondent but deficiencies have not been removed by the respondent. Respondent PIO was absent without any intimation to the Commission. Respondent PIO was directed to appear in person on the next date of hearing to clear the facts of this case along with directions to bring the information as per RTI application of the applicant and matter was adjourned for further hearing on 02.05.2018.
- On hearing held on **02.05.2018**, applicant, Sh. Jaswinder Singh intimated the Commission no deficiencies have been removed by the respondent till date. Respondent PIO was absent continuously second time without any intimation to the Commission and nor he/she file any reply in this regard. Show-Cause Notice was issued to him along with directions to appear in person on next date of hearing along with directions to remove the deficiencies pointed out by the appellant and matter was adjourned for further hearing on 28.05.2018.

- On the hearing held on **28.05.2018**, Sh. Ashish Tonk APIO cum SDO was appeared on behalf of the respondent and submitted a letter signed by that PIO cum XEN, W/S and Sanitation, Sub-Division, No. -1, Amritsar requesting therein for an adjournment to appear in person on today's hearing due to another hearing before the Addl. Session Judge Amritsar. This letter was also taken on record. Appellant, Sh. Jaswinder Singh pointed out deficiencies regarding the supplied information and pending information. One more opportunity was given to the respondent PIO to remove the deficiencies and supply the pending information along with directions to be appearing in person on the next date of hearing and matter was adjourned for further hearing on 02.07.2018.
- On hearing held on **02.07.2018**, Respondent, Sh. S.K. Sharma was appeared and stated that he has brought the requisite information to hand over to the complainant but he is absent. He submitted a copy of the requisite information vide Endst. No. 2204-05 dated 29.06.2018, which was taken on record. Appellant, Sh. Jaswinder Singh intimated the Bench of undersigned he is unable to attend hearing and requested for an adjournment. He also intimated that he has sent a letter in this regard to the Commission. After hearing the respondent and examining the documents placed on record, respondent PIO was directed to send the requisite information to the appellant through registered post and request of the appellant was granted; another opportunity was given to the appellant to represent his case in person or through any of his representative(s), who is well aware about the facts of this case along with advice to the appellant to go through the requisite information and point out the deficiency, if any, in the supplied information, in written to the respondent PIO along with a copy to the Commission, once he had received the requisite information from the respondent PIO, failing to which case will be decided on merits and matter was adjourned for further hearing on 30.07.2018. Hearing which was earlier fixed for 30.07.2018 was postponed and matter was adjourned for further hearing on 31.07.2018.

Appeal Case No. 2391 of 2017

- On hearing held on **31.07.2018**, Appellant, Sh. Jaswinder Singh pointed out deficiencies in the supplied information and handed over written reply regarding deficiencies to the respondent, Sh. Aashish Tonk during the hearing. Respondent, Sh. Aashish Tonk stated that he is not dealing in this case and requested for an adjournment. Last opportunity was given to the respondent PIO, Sh. R.P. Singh (XEN) to remove the deficiencies as pointed out by the appellant during the hearing. He was directed to appear in person on the next date of hearing positively to clear the facts of this case. A copy of this order was sent to him through registered post for his ready reference and matter was adjourned for further hearing on 17.09.2018.
- On hearing held on **17.09.2018**, both the parties were absent. Respondent PIO was not present for hearing but an email dated 14.09.2018 was received in the Commission stating that all the staff members of the concerned office on Election Duty and unable to represent this case. In that email he further requested for an adjournment. This mail was taken on record. Appellant, Sh. Jaswinder Singh was also not present for hearing but he intimated the Commission that he has sent an email stating that he is unable to attend today's hearing and requested for an adjournment. Another opportunity was given to the respondent PIO to comply of the previous order dated 31.07.2018 along with directions to appear in person on the next date of hearing positively to clear the facts of this case. It was also observed that no email had been received from the appellant as the appellant, Sh. Jaswinder Singh intimated the Commission through telephonic message. Complainant, Sh. Jaswinder Singh was advised to represent this case in person or through any of his representative on the next date of hearing, failing to which case will be decided on merit basis and matter was adjourned for further hearing on 15.10.2018.

- On hearing held on **15.10.2018**, Complainant, Sh. Jaswinder Singh was not present for hearing but an email dated 14.10.2018 has been received by the Bench of undersigned in connection with Complaint case no. 929/17 and Appeal case no. 2391/17 stating that he has not received reply in both the cases. This mail is taken on record. Respondent, Sh. Aashish Tonk stated that requisite information has already been supplied to the appellant. Respondent PIO was advised to send the requisite information to the appellant once again through registered post along with directions to represent copy of postal receipt before the Commission on the next date of hearing positively. Appellant, Sh. Jaswinder Singh is advised to go through the supplied information and point out, deficiency, if any, in written to the respondent PIO with a copy to the Commission, once he had received the requisite information. He was also advised to represent this case in person or through his representative(s) on next date of hearing, failing to which case will be decided on merit basis and matter was adjourned for further hearing on 12.11.2018.
- On hearing held on **12.11.2018**, Respondent, Sh. Sarabjeet Singh was appeared and stated that requisite information has already been supplied to the appellant. Appellant, Sh. Jaswinder Singh was absent without any intimation to the Commission. After hearing the respondent and examining the case file, it is found that respondent; Sh. Sarabjeet Singh does not know anything about this case. It was also found that on the last hearing held on 15.10.2018, Sh. Aashish Tonk was appeared on the behalf of the respondent and stated that he has brought the requisite information to hand it over to the appellant but the complainant was absent. Respondent PIO was advised to send the requisite information to the complainant through registered post along with directions to represent copy of postal receipt before the Commission and matter was adjourned for further hearing on 12.11.2018 i.e. today but the respondent PIO failed to do so.

Last opportunity was given to the respondent PIO to comply with the previous order of the Commission dated 15.10.2018, failing to which stern action will be initiated against him. It was also observed that appellant, Sh. Jaswinder Singh was also absent on the previous hearings held on 17.09.2018 and 15.10.2018. Last opportunity was also given to the complainant to represent this case in person or through any of his representative(s) on the next date of hearing, failing to which case will be closed in his absence and matter was adjourned for further hearing on 28.11.2018 i.e. today but respondent PIO failed to do so.

6. I am of the view that due to evasive attitude of the respondent PIO concerned, the appellant has suffered a lot of detriments for not getting the requisite information, I am of the view that compensation be awarded to the appellant, Sh. Jaswinder Singh.

7. Hence, I award an interim compensation of Rs. 2,000/- (Two Thousand Rupees Only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of Jaswinder Singh from the account of Public Authority and not from the individual's account.

8. Respondent PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.

9. Respondent PIO is also directed to supply the complete requisite information to the appellant before the next date of hearing along with directions to appear in person on the next date of hearing. He is also directed to file a reply to the Show Cause notice which was issued vide order dated 02.05.2018. A copy of this order be sent to him through registered post.

10. Matter is adjourned for further hearing on **31.12.2018 at 11:30 AM.**
