ORDER:

1. The complainant, **Manjit Singh**, filed this RTI application dated **11.12.19** and sought information **by way of copies of circulars vide which certain categories of employees were promoted from January to December 2006**, from the PIO o/o **PSTCL, Patiala**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **23.1.2020**. Notice was issued to the parties for first hearing in the Commission on **28.8.2020**.
2. Both parties are present through Video Conference from the office of Deputy Commissioner, Mohali. The complainant is represented by Sohan Singh. The respondent PIO represented by APIO-cum-Assistant Executive Engineer, Damandeep Singh, stated that the RTI application dated 11.12.19 was duly replied to the appellant by Registered Post on 30.12.19, whereby the complainant was informed that the information he seeks is publically available on the Website of the PSTCL, Patiala. The complainant also confirmed that he did receive such a reply.
3. The complainant is advised that as per the provisions of the RTI Act 2005, he cannot ask a public authority, in this instance PSTCL, for information that is already and freely available in the public domain.
4. The Commission also notes with distress that the complainant did not append the PIO's reply of 30.12.19 to his Complaint under Section 18, to this Commission. If he had done so, it would have saved both the PSTCL, this Commission and the complainant himself, a great deal of time and unnecessary expenditure.
5. There is no further cause for action and this complaint case is herewith **CLOSED**.
