ORDER

The RTI application is dated 23.7.2020 vide which the complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 29.7.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

- 3. The appellant states that the respondent has not provided the information so far. Whereas, a letter dated 30.7.2020 written to the complainant has been received from the respondent-Public Information Officer in which it has mentioned that the RTI application of the complainant relates to the Post Office. Therefore, the RTI application of the complainant has been returned in original along with the Indian Postal Order No. 51 F 134924 by the respondent-Public Information Officer.
- 4. However, the Commission is of the opinion that the respondent-Public Information Officer should have transferred the RTI application of the complainant under Section 6(3) of the RTI Act, 2005 to the concerned authority under intimation to the complainant.
- 5. Since, the Postal Department is not under the jurisdiction of the Punjab State Information Commission and the complainant has been apprised accordingly. Therefore, no action is required in this case.
- 6. The case is disposed of and closed accordingly.

This order may be read with reference to the previous order dated 16.9.2020.

- 2. The appellant states that the respondent-Public Information Officer has not provided the up to date status regarding the application of the appellant dated 8.7.2019 i.e. the complaint against Sh. Sarwan Singh Nambardar. However, the respondent-Public Information Officer states with regard to the complaint of the appellant, the notice was issued to Sh. Sarwan Singh and his reply was record but no further action has been taken till date. He further states that the appellant may sought the copy of the same after its completion which may take around two months.
