## ORDER

This order may be read with reference to the previous order dated 28.9.2020.

Since, the appellant has sought the similar information from the Public Information Officer o/o the Transport Minister, Punjab and the Principal Secretary Transport, Punjab and both the authorities have transferred the RTI application(s) to the State Transport Commissioner. As the information sought, appellant and the respondent-Public Information Officer are same, therefore, the cases are clubbed.

2. The appellant states that the respondents have not supplied the complete information. Whereas, the representative of the respondents states that regarding Point No. 2 of the RTI application, no enquiry was got conducted as has been sought by the appellant and the Point No. 3,4,5,6 and 7 relates to the enquiry report and nothing is available in this regard. Regarding Point No. 8 the representative of the respondents states that the office order dated 9.7.2019 has been supplied to the appellant vide which the complaint has been filed by the office. Regarding Point No. 1 i.e. the copy of the complaint filed by the appellant, the representative of the respondents states that since the appellant has filed the complaint he should have retained the copy of the complaint dated 12.4.2019 action taken of which has been sought by him.

3. After hearing both the parties, the respondent-Public Information Officer is directed to supply the copy of complaint as has been sought by the appellant before the next date of hearing.
