(To be read in continuity with earlier orders on 18.8.2021)

1. The RTI application is dated **22.10.2020** vide which the appellant has sought information **regarding illegal construction of Jagdev Industry and Enterprises**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **12.1.2021** and Second Appeal was filed in the Commission on **10.3.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **18.8.2021**.

2. The appellant is absent without intimation. This is notable here that this appellant has remained absent from all hearings including hearing before First Appellate Authority on 26.2.2021. As directed at the last hearing on 18.8.2021, the respondent PIO submitted vide Letter No. 309/DRG-C/D/PIO Dated 27.4.2021, that this information has already been supplied in Appeal Case No. 54/2021 vide Letter No. 438/DRG-C/D/PIO Dated 4.2.2021, wherein the appellant was informed that the requested information had been provided to him vide PIO's reply Letter No. 371/RTI/DRG/C/D Dated 28.12.2020, that the matter cited in the RTI application was still under Process.

3. Upon enquiry at this hearing, the respondent PIO represented, by Ms. Kashish Garg, APIO-cum-Building Inspector, is present via Video Conference from Ludhiana, has again stated that the matter cited in the RTI application regarding illegal construction pertaining to Jagdev Industry and Enterprises, is still under process. There has been no correspondence or communication from the appellant since the filing of this RTI application and nor has he appeared in any hearing.

4. Under the circumstances, this Commission is constrained to conclude that the appellant is satisfied with the information supplied to him and no longer wishes to pursue this case.

1. The RTI application is dated **2.1.2021** vide which the appellant has sought information **regarding bearing diary no. 3610/PS/R dated: 31.12.2020**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **10.2.2021** and Second Appeal was filed in the Commission on **30.3.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **18.8.2021**.

2. The appellant was present at the beginning of this hearing but has since left the venue. The respondent PIO, represented by Om Parkash, Inspector from Zone A, is present via Video Conference Facility from Ludhiana, stated that a reply was first sent to the appellant vide Letter No. 509 Dated 4.6.2021, wherein the appellant was informed that the complaint cited in the RTI application does not relate to the Municipal Corporation. In fact any action on the said complaint would lie in the jurisdiction of the Department of Local Government. In another letter (No. 541) was sent by registered post Dated 15.9.2021, the appellant was again reminded of the earlier reply as well as informed that the information requested on the basis of the complaint cited in the RTI application is personal and third party information as per the Hon'ble Supreme Court of India in Appeal No. 10044 of 2010.

3. The Commission concurs with the respondent PIO that not only is the information requested third party information, but also that no action on the complaint cited in the RTI application, relates to the Municipal Corporation Ludhiana.
