The complainant is advised to approach the first appellate authority in this behalf.

5. However, the respondent-APIO is directed to be more careful in dealing with the RTI applications in future. He is also directed to supply a photocopy of the registered receipt vide which the sought for information has been supplied to the complainant.

6. The case is ordered to be **disposed of and closed.**
