The Appellant, Sh. Tilak Raj is absent in today's hearing but a letter vide diary no. 2280 dated 28.01.2019 has been received in the Commission in which the Appellant stated that he had received the requisite information.

The Respondent/PIO is absent but a letter vide diary no. 2355 dated 29.01.2019 has been received in the Commission through which he has requested for an exemption from today's hearing.

After going through the case file, no further cause of action is required in this case. So this appeal case is **disposed off and closed.**
