

I have gone through Section 24 of the RTI Act, 2005 and it is codified that the RTI Act does not apply on certain organizations. Section 24(4) of the RTI Act, 2005 is as follows:-

"Nothing contained in this Act shall apply to such intelligence and security organization being organizations established by the State Government, as that Government may, from time to time, by notification in the Office Gazette, specify:

Provided that the information pertaining to the allegations of corruption and human

rights violations shall not be excluded under this sub-section:

Provided further that in case of information sought for is in respect of allegations of

violation of human rights, the information shall only be provided after the approval of the State

Information Commission and, notwithstanding anything contained in section 7, such information

shall be provided within forty-five days from the date of the receipt of request. "

The state government is empowered to exempt such intelligence and security

organizations and these organizations do not come within the ambit of RTI Act, 2005 provided

the information is related with the allegations of violations of human rights and regarding the

corruption. Along with security wing some other wings of the force has also been exempted.

In the present appeal case the appellant sought information from the office of the

PIO-cum-IGP, Security, Punjab and the Security wing of the Punjab police has been exempted

from the purview of the RTI Act, 2005 vide Punjab Government Notification dated 23.01.2006

and further the Punjab Government Notification dated 07.06.2016 as given in the reply of the

PIO.

So U/s 24 of the RTI Act, 2005 the security wing has been exempted from

imparting the information. Hence the present appeal case filed by the appellant does not lie for

getting the information from the security wing of Punjab police. Accordingly the present appeal

case is disposed of and closed.
