ORDER:

1. The RTI application is dated 22.6.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.7.2021 and second appeal was filed in the Commission on 8.9.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 29.3.2022 at 11.00 a.m. i.e. today.
2. In today's hearing, respondent states that RTI application was received on 23.06.2021 and reply/information was sent to the appellant on 15.07.2021, which was received by the appellant on 19.07.2021. He adds that till date no deficiency has been pointed out by the appellant in the supplied information. A reply vide letter no. No. 911/DSJ-13 dated 21.02.2022 was also sent to the Commission, which was received vide diary no. 3673 dated 22.02.2022 and is taken on record.
3. Appellant is not present despite being aware about the date of hearing, which means he is satisfied with the supplied information and does not want to pursue this case further as ample time has elapsed and he has not pointed out any deficiency in the supplied information.
4. In wake of above, no further cause of action is required. Therefore, this instant appeal case is **disposed of & closed**. Copy of the order be sent to the parties.
