





Ankit Sehgal submits that information sought was not furnished by the PIO on the grounds that the sought information is third party information. The respondent, Sh. Naresh Sharma submits that the sought information cannot be supplied as it is a third party information which is exempted u/s RTI Act 2005.

Keeping in view the facts of the case and perusal of the records placed in the case file the it is revealed that the type of information the appellant has solicited, reduced to the norms of the RTI Act.
