## Complaint Case No. 1013 of 2018

**Present:** Sh. Gurdev Singh, Complainant is present.  
Sh. Sanjiv Kumar, Clerk is present on behalf of Respondents/PIO.

### ORDER:

This case was last heard on dated 02.04.2019 with the directions to the Respondent/PIO to supply the requisite information to the Complainant and the show cause notice was issued in the name of PIO as well.

In today's hearing, the Complaint, Sh. Gurdev Singh states that the information which has been supplied to them is irrelevant in nature and still the copy of service rules relating to Washing boy has not been supplied to him till date.

On this, the representative of the Respondent/PIO, Sh. Sanjiv Kumar states that whatever information was available with them has been supplied to the Complainant and no more pending information is available with them apart from that. He further states that an affidavit relating to this has already been submitted in the Court vide email dated 27.04.2019, a copy of which is taken on record.

After discussing with both the parties and going through the case file, it has been observed that the Respondent/PIO did not comply with the previous order dated 02.04.2019, in which it has been clearly mentioned that "PIO is advised to give an affidavit to the effect that except these Rules, they have no other Rules dealing with the post of washing boy" but in the supplied affidavit the Respondent/PIO is using vague statements which clearly shows that they are trying to mislead the Court.

In view of the above, a penalty of Rs. 2,500/- (Rupees Two Thousand and Five Hundred Only) is imposed on the concerned PIO/Respondent, O/o General Manager, Punjab Roadways, Sri Muktsar Sahib. The amount of penalty i.e. Rs. 2,500/- should be deducted from the salary of the PIO and be deposited in the Govt. Treasury under the head "0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act".

PIO/Respondent is also advised to come in person and submit the proof of having deposited the penalty on the next date of hearing. PIO/Respondent is further advised to supply the complete

information or to clarify the facts in the form of affidavit as discussed in the Court before the next date of hearing. **Copy of this order be sent to the PIO through registered post.**
