O R D E R

Shri Joginder Singh, appellant filed RTI application dated 01.06.2020 and sought some information from the SPIO, O/o District Food and Civil Supplies Controller, Bathinda.

Today the case is heard through CISCO Webex Meetings Software.

The appellant is present today, whereas none has come present on behalf of the SPIO. The appellant stated that complete information has not been provided to him by the SPIO.

I have gone through the Order dated 16.02.2021 and the SPIO was directed to submit a duly attested affidavit that the information sought by the appellant through point no.4 of the RTI application is not available in the office of the SPIO and he was further directed to send the complete information regarding point nos.2 and 6 of the RTI application to the appellant.

The respondent though is absent today, but he has sent a mail to the Commission on 16.04.2021, diarized vide no. 8524, which is a copy of letter no. 2297 dated 31.03.2021 along with a copy of duly attested affidavit.

I have gone through the copy of duly attested affidavit sent by the SPIO and it is submitted by him that the information sought in para no.4 of the RTI application is not available in the office of the SPIO.
