Gurmukh Singh, Clerk, who appeared in today's hearing, orally claim that as per clause 40 of General Guidelines of 'Manuals of Instructions on conduct of Medicolegal Examination including Postmortem Examination' ; the Public Information Officer(PIO) can claim exemption Under Section 8 (1) (e) & (j) of the RTI Act if information pertaining to a victim/patient is sought by a third person, hence, the required information could not be supplied to the Appellant.

They also submit a copy of letter no. 637 dated 22.01.2019, appended to which is a copy of 'Manuals of Instructions on conduct of Medicolegal Examination including Postmortem Examination', which is taken on record.

As Section 8 (1) (e) & (j) of the RTI Act reads as under ;

8 (1) *Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen,—*

(e) *information available to a person in his fiduciary relationship, unless the competent authority is satisfied that the larger public interest warrants the disclosure of such information ;*

- (j) ***information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information:***

Provided that the information which cannot be denied to the Parliament or a State Legislature shall not be denied to any person.

Moreover, the Appellant has also succeeded to clarify the fact that information sought for by him through RTI request is in larger public interest.

After hearing both the parties and examining the documents placed on record, it has been found that a larger public interest is involved in disclosure of the information in this particular appeal-case.

Accordingly, the directions passed at para no. 04 vide orders dated 12.02.2019 in the instant appeal-case still stands (through which the respondent-PIO was directed to supply the names, numbers and addresses of the concerned persons, acknowledgement receipts, dockets and names of the patients), hence, the respondent-PIO concerned is directed to supply the certified copies of the required information to the appellant as per his queries raised through RTI request, before the next date of hearing, failing which action would be initiated against him under the provisions of the RTI Act.

The case is **adjourned to 29th July, 2019(Monday) at 11:00 A. M.**

Sh. Harmeet Singh, Junior Assistant-cum-APIO, states that information in connection with draw-register, if found available, would be given to the complainant positively.

On the assurance of Sh. Harmeet Singh, Junior Assistant-cum-APIO, the instant appeal case is **disposed of and closed** with the directions that the respondent PIO will fulfill the promise made by Sh. Harmeet Singh during the hearing in the Commission today.
