So, the SPIO, O/o Secretary, School Education, Mohali is directed that he should file reply to the complaint filed by the complainant/applicant and send the same to the Commission as well as to the complainant/applicant within 15 days. Non compliance of the Order of the Commission would be viewed seriously.
