Nevertheless, last and final opportunity is given to both the parties to represent this case in person or through their representative on the next date fixed to intimate the status of the instant appeal-case or the case would be decided on merits.

As the RTI is addressed to PIO office of Block Development and Panchayat Officer, Bhogpur and the RTI request is forwarded to Panchayat Officer Block Bhogpur vide letter dated 23.06.2022, which should have been should have been transferred to the concerned office within stipulated time under Section 6 (3) of the RTI Act and as the proper procedure was not followed by the respondent party., The Commission took a serious view of this casual approach of the respondent PIO.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer concerned of office of Block Development and Panchayat Officer, Bhogpur, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant.

He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed through facility of Software/application 'CISCO Webex Meetings', it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

Last opportunity is given to the respondent PIO concerned to supply the certified copies of the required information to the appellant as per queries raised by him through RTI request, through registered post within a week from today.

An opportunity is also given to the appellant to confirm whether he has received the information and also advised to point out deficiencies, if any, in the information supplied to the respondent PIO well in time so that the same could be removed by the respondent concerned.
