The respondent PIO is directed to facilitate the appellant to inspect the relevant official record on 02.08.2019 at 11:00 A. M. so that the appellant could identify the information. The appellant is also advised to avail the opportunity to inspect the relevant official record on 02.08.2019 at 11:00 A. M. to identify the information.

Both the parties mutually agreed to it during the hearing today.

ORDER

ORDER

This case was last heard on 29.05.2019 and the respondent PIO concerned was directed to supply the certified copies of the required information to the appellant as per his queries raised through RTI request.

Dr. Ravi Kant Sharma, Professor, who appeared in person in today's hearing with Sh. Gurmukh Singh, Clerk, orally states that the requisite information has been provided to the appellant, Sh. Vikram Vaid.

After examining the documents placed on record, it is found that the respondent through a reply vide letter no. 17815 dated 02.07.2019 signed by First Appellate Authority-cum-Principal, Government Medical College, Amritsar, which has been received in the Commission vide Diary No. 12802 dated 03.07.2019, has intimated the Commission that the requisite information, has been provided to the appellant, Sh. After hearing the parties concerned, going through the queries raised by the appellant in his RTI request and the response given by the respondent PIO concerned, it emerges that the respondent has given information at point no. 06 of the RTI request to the appellant and part information has been given to the appellant at point no. 01 and 03 and a reply has been given to the appellant at point no. 02, 04 and 05 of the RTI request.

Accordingly, another opportunity is given to the respondent PIO concerned to supply the information at point no. 01 and 03 of the RTI request regarding MLR/PMR issued and forwarded to Police Post, Majitha Road, Guru Nanak Hospital, Amritsar for the period from 18.09.2013 to 14.02.2014 to the appellant before the next date of hearing. At point no. 02, 04 and 05 of the RTI request, the PIO is directed to file a written reply in an affidavit to the Commission, stating that as far as the queries raised by information seeker in his RTI request is concerned, there is no other case other than the 03 cases, which have already been provided to the appellant in response to the RTI request and the documents collected from the concerned Police Station is genuine, on the next date of hearing, failing which action would be initiated against him (respondent PIO concerned) under the provisions of the RTI Act.
