The Commission has received a mail sent by the PIO-cum-Sub Registrar, Samana on 26.07.2019 diarized vide no.14351, which is a copy of letter no.29 dated 24.07.2019. The said letter is in the file of the Commission.

I have gone through the letter sent by the PIO and it is submitted that Shri Achhru Bansal, appellant has not come present in the office of the PIO till 24.07.2019 for the inspection of the record and the PIO requested to dispose of the appeal case.

I have gone through the RTI application dated 17.05.2018 and the appellant requested for inspection of the concerned files mentioned in the para 1 and 2 of the RTI application, but he never visited the office of the PIO-cum-Sub Registrar, Samana for inspection of the files.

I have gone through the Order dated 13.02.2019 passed by the predecessor Bench of the Hon'ble State Information Commissioner, Shri A.S. Chanduraian and the appellant was directed to inspect the record in the office of the PIO on 22.02.2019. After the retirement of Hon'ble SIC, Shri A.S. Chanduraian, the case file was sent to the present Bench for hearing.

On 28.05.2019, Shri Achhru Bansal, appellant was absent without any intimation to the Commission and he was directed to visit the office of the PIO for making inspection of the concerned files on 10.06.2019 at 10:00 A.M. Then on 01.07.2019 the appellant was again absent and he was directed to visit the office of the PIO-cum-Tehsildar, Samana for inspection of the concerned files on 10.07.2019 at 10:00 A.M.

Shri Achhru Bansal, appellant sought inspection of the files through his RTI application and was directed by the Commission that he should visit the office of the PIO on specific dates, but he has not visited the office of the PIO for making inspection of the concerned files.

I have gone through the Order dated 01.07.2019 and a last and final opportunity was granted to the appellant that in case he would not come present for the inspection then the case will be disposed of.

The Commission has received a mail sent by the PIO-cum-Sub Registrar, Samana that the appellant has not come present till 24.07.2019 for inspection of the concerned files , whereas the Bench has directed the appellant to make inspection on 10.07.2019.

So, it seems that the appellant is not interested in making the inspection of the concerned files that is why he has not visited the office of the PIO for inspection of the records, neither he is coming present before the Bench at the time of hearing and nor he sent any mail.

So, the present appeal case is **disposed of and closed**.
