ORDER

1. Read this case with reference of previous hearing dated 19.06.2019.
2. Sh. Mohan Singh Sachdeva submitted a reply to the Commission signed by Principal cum PIO O/o Devi Sahai Sanatam Dharam Sr. Sec. School, Jalandhar with context to interim order passed by undersigned on 19.06.2019 mentioning therein that the appellant has not justified reasons for his dissatisfaction as nothing wrong was there in affidavit submitted. He had rightly submitted that the Devi Sahai S.D. Education board was entirely a new body with the purpose to have effective management of various schools, colleges, and properties under the board. As such, it was neither a division nor an amalgamation or succession and it was evident from the contents of the resolution itself as it was only a change of name. It was also added therein that the PIO filed affidavit based on documents/record available, which the complainant had already inspected. It was also mentioned therein that if any particular document / information has already been in the possession of the complainant, no prejudice has been caused to him simply because of the reason that it has not come from the possession of PIO. PIO reiterated that he correctly stated that a new Society registered with number 477 but as per resolution produced by the appellant it was change of name from **Education Board Devi Sahai S.D. Higher Secondary School, Jalandhar City to Devi Sahai S.D. Education Board Jalandhar City.**
3. Sh. Mohan Singh Sachdeva also stated verbally that out of 8 founder members of governing body of **Education Board Devi Sahai S.D. Higher Secondary School, Jalandhar City** 7 members are not alive and living 8th member is too old to take care of or to even participate in working society and not even well conscious to be aware of it.
4. Sh. Parveen Kumar Budhia states that previous order dated 19.06.2019 details of High Court orders regarding the name of **Devi Sahai S.D. Education Board Jalandhar City** were not included but after examining the case file it is found that reference of order passed in Civil Suit by Sh. Suresh Kumar Goyal, PCS. Addl. Civil Judge (Sr. Divn), Jalandhar dated 30.01.2013, were considered and taken on record. The respondent has also filed a reply as mentioned above in this regard.
