First appeal was filed with the First Appellate Authority (hereinafter FAA) on 12.12.2019 and the second appeal was filed in the Commission on 15.06.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case was scheduled to be heard today through V.C. at DC Office, Gurdaspur. However, on contacting the official concerned with the V.C. facility, it is reported that the slot has been booked for a meeting to be taken by Shri Tejveer Singh, IAS, Principal Secretary to Chief Minister, Punjab, hence, the slot for holding Video Conferencing in D.C. Office, Gurdaspur would not be available to the Bench.

3. In view of the above, the matter is adjourned. **To come up for hearing on 15.09.2020 at 11.30 AM through V.C in the office of DC Gurdaspur.** Copies of order be given to the concerned parties.
