6. After hearing both the parties and examining the case file it is clear that Sh. Arjun Shereon had asked "copy of the order of inquiry" and the same was supplied to him in response to his original application under RTI Act. It is settled proposition of law that the public authority is bound to supply only that information to the applicant which is asked for by the Appellant. The Public Authority is not bound to supply any co-related information which may be in the mind of the applicant or which is not held by the Public Authority. The information sought by the appellant is not held by public authority at Rajiv Gandhi National University of Law (RGNUL) then the respondent university cannot be expected to create or supply information not held by it.

The respondent has cleared in his reply that the enquiry report in question is not held by public authority of the respondent university and it has no authority to direct its superior authority i.e. the Chancellor.

The respondent states that the needed information which is not other-wise stated in the RTI i.e. enquiry report" is with the office of Chancellor. He further states that the RTI of the Appellant cannot be transferred to the concerned office under Section 6(3) of the RTI Act 2005 as the PIO is not designated there.

7. Since, the appellant is satisfied with the information provided by the respondent except point no. 19, hence the respondent is directed to file an affidavit regarding point
