Shri J.S. Jaswal (Brig.), appellant filed RTI application dated 18.02.2020 before the SPIO, O/o Commissioner of Police, Jalandhar and sought information regarding Shri Bimal Kant, Inspector (now ACP). The SPIO has sent reply to the appellant vide letter no.323-D dated 23.05.2020 and denied the information U/s 8(1)(j) of the Right to Information Act, 2005. Aggrieved with the reply of the SPIO, the appellant filed First Appeal before the First Appellate Authority on 31.05.2020, which was decided and the First Appeal of the appellant was dismissed by the First Appellate Authority. Then the appellant filed Second Appeal before the Punjab State Information Commission on 02.12.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for 17.02.2021 to be heard through CISCO Webex Meetings Software.

I was on medical leave, so the case was heard by the Ld. State Information Commissioner, Smt. Preety Chawla on 17.02.2021 and after hearing, both the parties were directed to appear in person before the Commission on the next date of hearing, but on the next date of hearing i.e. 06.05.2021, the case was postponed and not heard.

Today on 29.07.2021, I have heard the present appeal case. The appellant, Shri J.S. Jaswal is present and ACP Balwinder Iqbal Singh Kahlon is present on behalf of Shri Gurmeet Singh, SPIO- cum-DCP, Jalandhar. I have heard both the parties and perused the case file. Shri J.S. Jaswal, appellant has filed the RTI application and sought the following information:

"That Sh.Bimal Kant, Inspector (Now DSP) was suspended from duty for dereliction of duty, with reference brutal attack on Brig J.S. Jaswal, VrC, SM, FIR No. 123 30/05/2017. You are requested to please provide following documents:-

- i) Copy of Suspension order, no. 46249-S6 dated v1.6.2017.
- *ii)* Copy of Charge Sheet.
- iii) Copy of Inquiry report, along with recommendations of the Inquiry officer, endorsements by the Intermediary authorities, & Legal Opinion, & all the attachments/exhibits.
- iv) Copy of Final Orders of The Commissioner of Police, Jalandhar. "

The information sought by the appellant was denied by the SPIO U/s 8(1)(j) of the Right to Information Act, 2005 and the reply was sent to the appellant vide letter no.323-D dated 23.05.2020.

I have gone through the RTI application dated 18.02.2020 filed by the appellant and he sought information regarding Shri Bimal Kant, Inspector (now ACP), who was suspended from duty for dereliction from duty. The detailed RTI application is given above. The main grudge of the appellant is that there was Civil Court decree in his favour and he filed execution before the Civil Court and during the execution proceedings the Civil Court issued warrant for delivery of possession and warrant officer has to come personally on the spot for the delivery of the possession and when the appellant was going on road on his motor cycle, the other party attacked and injured him and he was brought to the hospital and his medical was conducted and his statements were recorded by the police and FIR No. 123 dated 30.05.2017 was registered at Police Station, Rama Mandi, Jalandhar under Police Commissionerate, Jalandhar.

I have gone through the contents of the FIR No.123 dated 30.05.2017. The appellant has not leveled any allegations against the police officer.

The appellant filed Second Appeal and I have gone through the grounds of the appeal and the appellant made allegations against Shri Bimal Kant, Inspector (Now ACP), for his failure to discharge his duty i.e. failure to protect the life and liberty of the complainant. He submitted that the SHO, Shri Bimal Kant has not provided proper security to him. Though it is the duty of the SHO to maintain the law and order in the police station area, but it is not possible that the SHO should be physically present with every person.

I have perused the case file and gone through the contents of the FIR. There are allegations against the accursed persons i.e Sewa Singh and others and no allegations against the police personnel. It is pertinent to mention here that the appellant now making the allegations against Bimal Kant, ACP which is after thought of the incident as no allegations have been leveled against Bimal Kant in the FIR.

The information sought by the appellant has been denied U/s 8(1)(j) of the Right to Information Act, 2005, which is as follows:-

" **Exemption from disclosure of information**: - Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen:

Information which relates to personal information the disclosure of which has not relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information."

The SPIO-cum-DCP, Jalandhar has denied the sought for information regarding Shri Bimal Kant, Inspector (now ACP, HQ, Jalandhar) U/s 8(1)(j) of the Right to Information Act, 2005 being his personal information. The SPIO has sent the reply to the appellant and also sent the reply to the appeal to the Commission.

I have gone through the RTI application and the reply submitted by the SPIO and the other papers on the file and heard Shri J.S.Jaswal, appellant and ACP Balwinder Kumar Kahlon. The appellant stated that though the information is related to Shri Bimal Kant, ACP and is exempted U/s 8(1)(j) of the Right to Information Act, 2005, but it may be disclosed in the larger public interest.

The SPIO has relied upon the Judgement of the Hon'ble Supreme Court in SLP No. 27734 of 2012 titled Girish Ramchandra Deshpande Versus Central Information Commissioner and others and sent a copy of the same to the Commission. I have gone through the Judgement of the Hon'ble Supreme Court on Section 8(1)(j) of the Right to Information Act, 2005. The information which is related with the service career of an employee and is primarily a matter between the employee and the employer and normally those aspects are governed by the service rules which fall under the expression "personal information", the disclosure of which has no relationship to any public activity or public interest. On the other hand, the disclosure of which would cause unwarranted invasion on the privacy of that individual.

Shri J.S. jaswal, appellant agitated that the information though is personal, but it may be provided in the larger public interest. I after hearing both the parties and gone through the Judgement of the Hon'ble Supreme Court and after the perusal of the case file, is of the opinion that the appellant is seeking the information only being the personal grudge and personal reason against a police officer and when he was asked to explain that how the larger public interest involves to justify the disclosure of personal information, then the appellant could not satisfy the Commission that it would be for the larger public interest.

So, I am of the view that the information sought by the appellant is the personal information of third party ACP Bimal Kant (now retired) and the SPIO has rightly denied the information U/s 8(1)(j) of the Right to Information Act, 2005 as no larger public interest is involved in the disclosure of personal information sought through RTI application dated 18.02.2020 filed by the appellant. The appellant has simply seeking information for his personal reasons and not for the larger public interest. It is therefore, the appeal case filed by Shri J.S. Jaswal, appellant is hereby **dismissed.**

Shri Rajiv Kumar Nanda, appellant filed RTI application dated 17.12.2018 before the SPIO, O/o Chief Secretary, Govt. of Punjab, Chandigarh and he sought some information related to FIR No.5 dated 09.01.2018, registered under Sections 302/307 IPC at Police Station Valtoha, Distt. Tarn Taran.

Today Advocate Joginder Pal Devgan is present on behalf of Shri Rajiv Kumar Nanda, appellant. DSP Dilbagh Singh is present on behalf of Shri Dhruman H. Niwale, IPS, SPIO-cum-SSP, Tarn Taran and ASI Rajinder Singh is present on behalf of the SPIO, O/o Intelligence, Punjab, Mohali.

I have gone through the Order dated 11.11.2020 and the SPIO, O/o Intelligence, Punjab, Mohali was directed that the attested copy of inquiry report conducted by Shri S.S. Maan, IPS, AIG, State Special Operation Cell, Amritsar, which was sent through letter no.5005 dated 16.11.2018 be sent to the appellant through registered post and compliance be sent to the Commission.

I have gone through the Order dated 10.02.2021 passed by the Ld. State Information Commissioner, Smt. Preety Chawla and on that date ASI Rajinder Singh, O/o Intelligence, Punjab, Mohali was present and he stated that in compliance to the Orders dated 11.11.2020 and 15.12.2020 passed by Shri Avtar Singh Kaler, Hon'ble State Information Commissioner, Punjab, the attested copy of inquiry report conducted by Shri S.S. Maan, IPS, AIG, State Special Operation Cell, Amritsar, was sent to the appellant through registered post vide letter dated 15.01.2021 and a copy of the same has also been sent to the Commission as

compliance. The respondents O/o SSP, Tarn Taran submitted a duly attested affidavit dated 10.02.2021 to the Commission, in which it was submitted that the appellant sought information regarding FIR No. 5/18 under sections 302, 307, 506/336, 148, 149 IPC registered at Police Station Valtoha and as per the Order of the Commission, the attested copies of 94 pages of information i.e. copies of applications, statements and FIRs were provided to the appellant by hand and It is further submitted in the affidavit that in appeal case no.2419 of 2019 the information which was related with the office of SSP Tarn Taran has already been provided to the appellant.

Today at the time of hearing DSP Dilbagh Singh, who is present on behalf of the SPIO-cum-SSP, Tarn Taran, stated that 94 pages of information has been provided by hand to the appellant vide letter dated 20.10.2020 and again 7 pages were provided to the appellant and except that no other information is available with the office of the SPIO. He further stated that they have submitted an affidavit regarding this, which is in the file of the Commission.

ASI Rajinder Singh O/o Intelligence Punjab, Mohali stated that they have sent the attested copy of inquiry report conducted by Shri S.S. Maan, IPS, AIG, State Special Operation Cell, Amritsar to the appellant through registered post vide letter dated 15.01.2021.

Advocate Joginder Pal Devgan, who appeared on behalf of the appellant stated that the appellant had received the inquiry report conducted by Shri S.S. Maan, IPS, AIG, State Special Operation Cell, Amritsar, and also received the information about 100 pages as stated by DSP Dilbagh Singh. But even then he is agitating that incomplete information has been provided by the District Police. He was asked by the Commission to point out that which documentary information has not been provided to the appellant which is in the custody of the public authority i.e. SSP, Tarn Taran, but Advocate Joginder Pal Devgan failed to reply the query put up by the Commission.

So, as per the Order dated 11.11.2020 the office of the SSP, Tarn Taran and the office of Intelligence, Punjab Mohali both have provided the information to the appellant and DSP Dilbagh Singh who appeared on behalf of the SPIO-cum-SSP, Tarn Taran stated that they have provided the information which was in the custody of the public authority and except that no other documentary information sought by the appellant remained to be provided.

So, the matter involved in the appeal case has been resolved and the information has been provided to the appellant. Therefore, the present appeal case is **disposed of and closed.**
