1. This order may be read with reference to the previous order dated 23.08.2022 vide which **show cause notice was issued to the respondent PIO** and matter was adjourned for further hearing on 29.09.2022 i.e. today.
2. In today's hearing, respondent PIO is absent in spite of show cause notice was issued to him by name vide order dated 23.08.2022 but he has not paid heed towards the same. He was also absent on the previous hearings held on 27.04.2022, 26.07.2022, 23.08.2022 and today itself, which is indeed a serious matter.
3. The perusal of the files shows that, appellant accepted that he has received information in connection with point no. 3 vide order dated 18.11.2021 passed by the Bench of the then Ld. SIC, Sh. Hem Inder Singh. Directions were given to the respondent PIO on 18.11.2021 to send an affidavit in original stating therein that no more information is available with a copy to the Commission but as per the case file not received by the Commission yet.
4. From the material on record, it transpires that there has been unnecessary delay in conveying the correct State of affairs to the appellant in respect to his request for information. No explanation for delay has been given by him. Rather, his failure to even respond to the directions issued to him by the Commission reinforces the fact that he has been without any reasonable cause guilty of remissness in the discharge of his duties, therefore, deserves to be penalized.

5. In view of the defying attitude of the concerned respondent PIO, Municipal Corporation, Amritsar neither attending the court nor submitting any explanation for the directions issued to him within the time schedule as prescribed under the RTI Act 2005, the court comes to a logical conclusion that it is a fit case for the **imposition of penalty amounting to Rs. 10000/- (Rupees Ten thousand only) upon the concerned respondent PIO.** However, taking a lenient view, I impose a penalty of Rs. 10,000/- (Rs. Ten thousand only) on the respondent PIO. The Drawing and Disbursing Officer of the office of MC, Amritsar is directed to deduct the amount of penalty of Rs. 10000/- from the salary of the concerned respondent PIO and be deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-
 - "0070-Other Administrative Services
 - 60 other Services
 - 800-Other Receipts
 - 86-Fee under the RTI Act, 2005
6. Respondent PIO is also directed to supply the information in connection with point no. 1 and 2 within seven days after receipt of this order under intimation to the Commission.
