1. 1. The RTI application is dated **20.8.19** vide which the appellant has sought information **regarding copies of letter dated 27.6.19 to Commissioner of Police, Amritsar, action taken report on said letter, police report and investigation report etc.** as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **24.9.19** and second appeal was filed in the Commission on **7.11.19** under Section 19 of the Right to Information Act, 2005. The case was last heard on **27.8.2020**.

The affidavit must specifically state that the record pertaining to point 3 as to whether the Police Report/Investigation Report and other documents that were given to the applicant/complainant (cited in the RTI application) Gulshan Kumar, were requested by him. If so, details regarding the request / application made by Gulshan Kumar (including a certified copy). The affidavit must also state, as earlier, that information / documents supplied to this appellant and to Gulshan Kumar are the same, and that no additional documents / information has been supplied to the aforesaid Gulshan Kumar. The original affidavit be handed over to the appellant and a legible photocopy to be sent via email and by registered post to this Commission.

1.
