ORDER : The appellant applied to PIO to supply following information vide RTI application dated  
31.01.2020 :

1. *Certified copies of transfer orders of the department and entries made in service book from 01.01.2010 onward of Shri Charanjit Singh, Dy.DEO(SE), Ludhiana and Ms. Sukhwinder Kaur, Principal, GSSS Ekolaha.*
2. *Certified copies of complaints from 01.01.2010 onward against Shri Charanjit Singh, Dy.DEO(SE), Ludhiana and Ms. Sukhwinder Kaur, Principal, GSSS Ekolaha, enquiry reports, noting files, supporting documents and decisions taken by the department.*
3. *Certified copies of appeals, enclosed documents made by Shri Charanjit Singh, Dy.DEO(SE), Ludhiana and Ms. Sukhwinder Kaur, Principal, GSSS Ekolaha, against the decisions and further decisions taken by the department against the appeals so received from the above officials w.e.f. 01.01.2010 onward..*
4. *Certified copies of decisions taken against Shri Charanjit Singh, Dy.DEO(SE), Ludhiana and Ms. Sukhwinder Kaur, Principal, GSSS Ekolaha by the department, copy of punishment orders and pages of service books where such entries made.*
5. *Certified copies of charge-sheets issued by the department against above officials.*

When no reply was received from the PIO, he filed first appeal with the FAA on 03.03.2020. On getting no information from the FAA, he filed second appeal in the Commission on 29.06.2020.

2. Today, the Appellant reiterates his earlier stand that till date no information or reply has been received from the respondents.

3. The Respondent states that the demanded information relates to third party. He has also emailed point-wise reply vide letter dated 29.10.2020 to the Commission with a copy to the appellant which is taken on record.

4. From the examination of papers available in the case file and point-wise reply of the Respondent, it is observed that the sought for information is a third party information.

5. In view of the above, **the case is ordered to be disposed and closed.** Copies of order be sent to the parties.
