## ORDER

The RTI application is dated 21.5.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 30.6.2020 and second appeal was filed in the Commission on 24.8.2020. under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for 12.10.2020 but could not be heard due to administrative reasons and further adjourned to 29.10.2020.

2. The representative of the respondents states that the appellant is seeking the personal information of 3<sup>rd</sup> party which cannot be supplied as per the provisions of the RTI Act. A letter has also been written by the respondent-Public Information Officer to the Commission, which is taken on record. Whereas, the appellant states that the directions may be issued to the respondents to supply the same as he is having the consent of the 3<sup>rd</sup> party.

3. After deliberations, the respondent-Public Information Officer is directed to adopt the procedure under Section 11 of the RTI Act, 2005 and get the consent from the 3<sup>rd</sup> party in this regard before the next date of hearing. In case, the 3<sup>rd</sup> party has no objection in supplying the information to the appellant, the respondent-Public Information Officer is directed to supply the same to the appellant else the submissions be sent to the Commission for consideration before the next date of hearing.
