3. The representative of the respondents states that the information pertaining to Point No. 12 was remained pending as per the last order which has already been sent to the complainant vide letter No. 15.10.2020 and a copy of the same has been sent to the Commission, which is taken on record. The representative of the respondents further states that the information has already been supplied to the complainant as per the official record pertaining to his RTI application along with a specific reply wherever necessary and nothing more is available on record which could be replied/supplied to him. The complainant also states that he has received the information in accordance with his RTI application and is satisfied with the reply/supply of information by the respondents.

Copy of letter bearing No. NIL dated NIL has been received from the respondent-Public Information Officer through whatsapp, which is taken on record.

4. The representative of the respondents states that the concerned record has also inspected by the appellant and nothing more which can be supplied to the appellant in this regard. The appellant agrees with the submissions of the representative of the respondents and states that he has no objection in case the case is disposed of as the information as available on record has been supplied.

5. According to the submissions of the appellant, no more action is required in this case. Hence, the case is disposed of and closed.
