
This order may be read with reference to the previous order dated 13.11.2018.

2.     The Respondent states that he has brought the complete information today in the Commission to be handed over to the Appellant. A Copy of the same is handed over to the Appellant.

2. Today no one has appeared on behalf of the Respondent.
3. The Appellant states that the complete information has not been provided to him.
4. The perusal of the file shows that no one has appeared on behalf of the Respondent. They have not even bothered to inform the Commission about their absence. The appellant has filed RTI with the o/o SHO, Police Station, Balachaur, Nawanshahr on 22.03.2018 but incomplete information has been given to him so far, after lapse of more than eight months, which shows that the respondent has no regard for the orders issued by the Commission. This is indeed a serious matter.
5. In view of the foregoing, PIO is directed to show cause why action should not be taken against him for not attending the hearing inspite of order of the Commission. He should file a written reply in response to the show cause notice as to why the Complainant should not be compensated for the mental harassment suffered by him in getting the information. In addition to the written reply PIO is hereby given an

opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.
