S.P.Goyal, it is mostly humbly submitted that out of 8 paras of the reply dated 16.10.2018 of the respondents, appellant has not disputed reply to para No.1, 2, 3, 6 and 8, thus it needs no further comments and further the appellant disputes only contents of Para No. 4, 5 and 7.
3. It is submitted at para No.4 pertains to para No.29, 32 and 40 of the RTI application dated 20.02.2018, but requisite reports cannot be supplied being privileged documents and relating to the judicial functions of the Court.
4. As regards Para No.5 of the replication, it is submitted that it pertains to Para No.38 of RTI application dated 20.02.2018 and appellant has been intimated vide impugned reply dated 23.03.2018 that information sought under this para being vague cannot be supplied.
5. As regards para No.7 of the replication, it pertains to Para No.27, 28,31,34 and 37 of RTI application dated 20.02.2018, however, the information sought under these paras cannot be supplied being queries/opinions etc. in view of law laid down by the Hon'ble Supreme Court of India in Central Board of Secondary Education & Another Versus Aditya Bandopadhyay & others [(2011) 8 SCC 497]

After hearing the respondent-PIO and perusing the record available on the case file, it is ascertained that complete and satisfactory information has been provided by the respondent to the appellant.
