He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed through facility of Software/application 'CISCO Webex Meetings', it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

Another opportunity is given to the respondent PIO concerned to supply the certified copies of the required information to the appellant as per queries raised by him through RTI request, through registered post or e-mail with a copy to the Commission by next hearing.

An opportunity is also given to the appellant to confirm whether he received the information or not. He is also advised to point out deficiencies, if any, in the information supplied to him, in writing, to respondent PIO so that the same could be removed by the PIO concerned.
