- (ii) taking notes, extracts or certified copies of documents or records;
- (iii) taking certified samples of material;
- (iv) obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device.

The representative of the respondents also submits that the appellant has not deposited the document fee amounting to Rs.600/- so the information pertaining to Point No. 2 to 6 of the RTI application has not been supplied to him due to non deposit of requisite fee. The relevant portion of the submissions made by the respondent in this regard is reproduced below:-

With reference to your notice of appeal bearing No.PSIC /Legal/ 2022/6076 dated 15.02.2022 received on 21.02.2022 on the subject cited above, I am to state that the appellant sought information vide letter dated 19.8.2016 (Annexure, A-1)) with regard to action taken on his application dated 26.7.2016 on (Annexure, A-2) 15 points, out of which information of Point No.2 to 6 was related to this office only and rest of the information was concerned with various other public authorities.

In this respect it is submitted that the appellant was informed to deposit an additional fee of Rs.600/- for the estimated information of about 300 pages vide letter No.42(2)/PIO/2016/16138 dated 30th august 2016 (Annexure, A-3)) but he did not send additional fee.

It is also pertinent to mention here that the appellant did not avail the opportunity of first appeal.
