ORDER:

(To be read in continuity with earlier orders on 24.11.2021 and 10.3.2022)

1. The RTI application is dated **8.2.2021** vide which the appellant has sought information **regarding the construction of a concrete road from Sardar Cloth House upto Gurdwara Kalgidhar Sahib in Four points,** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **12.3.2021** and Second Appeal was filed in the Commission on **30.4.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **10.3.2022**.

2. Both parties are absent. In a reply to the appellant, in view of the Commission's Order of 10.3.2022, the respondent PIO contends that the road cited in the RTI application will have to be broken to retrieve a sample and such an act could weaken the road.

3. The respondent PIO has furnished an attested copy of the lab test report pertaining to the aforesaid roads. Meanwhile, the appellant has informed the Commission via telephone that he has received the information supplied.

4. This Appeal Case is accordingly **Disposed of.**
